STATE CERTIFICATION OR LICENSURE REQUIREMENTS

THE STATE OF OKLAHOMA REQUIRES EACH PERSON TO ATTEND THE REQUIRED HOURS FOR THE PROGRAM, SUCCESSFULLY COMPLETE ALL AREAS OF TRAINING WITH SATISFACTORY STATUS AND PAY ALL FEES DUE. UPON GRADUATION YOU MUST SEND AN APPLICATION FOR TESTING WITH A \$35 MONEY ORDER TO THE OSBCB. UPON PASSING BOTH THE WRITTEN AND PRACTICAL TEST YOU WILL SEND AN APPLICATION FOR LICENSE WITH THE APPROPRIATE FEE TO OBTAIN YOUR LICENSE.

STATE REQUIRED INFORMATION

4. \$5 Money Order (made out to Oklahoma State Board of Cosmetology and Barbering)
5. 2x5 Full Face Photo of Applicant

PRE-REQUISITES FOR EMPLOYMENT

Any person interested in the Cosmetology or Barbering or related occupations must attend a attend the Oklahoma State Board of Cosmetology and Barbering required hours specified for the chosen program. Upon completion of the program, you are required to register for and pass the OSBC&B practical and written test. Upon passing both you will then be required to make an application for a license. License must be renewed yearly by the end of the persons birth month.

Any person attempting to obtain a license must have a Social Security Number and be a legal citizen of the United States of America. All test administered by the OSBC&B will be in English.
